Other Fees & Disclosures:

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are five or more days late in making a payment.

Cash Advance Fee (Finance Charge):

\$5.00 or 1.00% of the amount of each cash advance, whichever is greater, however, the fee will never exceed \$25.00.

Returned Payment Fee:

\$21.00 or the amount of the required minimum payment, whichever is less.

Rush Fee:

\$15.00.
